Narrative Date: 9/30/2012

On 30Sep12, at approximately 0106hrs, I responded to the Circle K at Thomasville and Bannerman Rd in reference to a disturbance.

Upon arrival I made contact with ~~#####~~ who gave the following sworn statement;
She went to ~~#####~~ house at ~~#####~~ to "hang out". ~~#####~~ and her boyfriend came home and were upset that ~~#####~~ was there. They asked both of them to leave. As she was walking through the garage she noticed dogs in a kennel barking and whining. She tried to let them out and ~~#####~~ "knocked her to the ground". She stated ~~#####~~ continued to "swing" on her while she was on the ground. She stated she never tried to hit ~~#####~~

~~#####~~ was crying and bleeding from her left knee, right wrist, left forearm and left foot. She also had an abrasion on her left cheek. I took photos of all injuries and the photos were placed into the LCSO property and evidence room.

I spoke with ~~#####~~ who gave me the following sworn statement;
He witnessed ~~#####~~ "attack" his friend ~~#####~~ in the garage and "swing" on her multiple times.
Mr. ~~#####~~ stated there were not other witnesses to the crime. Ms. ~~#####~~ told me she just met Mr. ~~#####~~ earlier in the night.

I responded to the incident location and made contact with ~~#####~~ Her boyfriend, ~~#####~~ was also there. He told me he never saw any physical contact between the two females. I read ~~#####~~ Miranda by card and she agreed to speak with me. She stated she was upset that ~~#####~~ was there with a girl because he wasn't supposed to be there anymore. As ~~#####~~ and ~~#####~~ were leaving she saw ~~#####~~ about to let her dogs out so she "pushed" her away from the dogs which caused her to fall down. She stated she did not do anything else other than push her.

~~#####~~ fit the criteria for a notice to appear. She signed the notice and was provided a copy. She had no visible injuries and stated ~~#####~~ "tried to kick her" while she was on the ground.

Ms. ~~#####~~ was provided a victims rights pamphlet.

Mr. ~~#####~~ stated Mr. ~~#####~~ had been living there and still had property in the house but had not been staying there recently. He was advised to legally evict Mr. ~~#####~~ or if Mr. ~~#####~~ removed all of his belongings and moved out voluntarily he could be trespassed from the property.
